GENERAL DESCRIPTION

The State Office of Risk Management (SORM) is looking for a Risk Manager who will collaborate with internal and external stakeholders and facilitate the evolution of risk management for state agencies. As a SORM Risk Manager, this person will assist clients in creating a culture of enterprise risk management to proactively manage hazard, operations, financial, and strategic risk and effectively integrate risk management into agency operations. This person will provide consultative services with program participants to conduct broad risk management support including a full range of assessments, recommendations, and advocacy. Risk Managers at SORM serve as an authority on safety and loss control programs, and work closely with our workers' compensation claims adjusters, continuity of operations, insurance specialists, and other staff to convey professional knowledge of all programs. Conducts on-site consultation (OSCs) of properties and facilities to identify hazards and risk exposures

Conducts risk management program reviews (RMPRs) and safety program evaluations.

Administers guidelines adopted by the board for a comprehensive enterprise risk management program applicable to all state entities to reduce property, liability and workers' compensation losses

Reviews and analyzes state entities' risk management policies and procedures

Reviews files, reports, and programs for compliance with applicable state and federal laws

Prepares technical and comprehensive reports, plans, and procedures for developing risk management program reviews (RMPRs) and on-site consultations (OSCs)

Tracks and records the risk management recommendations using a Risk Management Information System (RMIS)

Cooperates with other oversight entities to implement viable health and safety, risk financing, continuity of operations, insurance and workers' compensation administration programs for state entities

Performs related work as assigned

Attends work regularly in compliance with agreed-upon work schedule

Statewide overnight travel as required

Ensures security and confidentiality of sensitive and/or protected information

Complies with all agency policies and procedures, including those pertaining to ethics and integrity
